

Pulverized Fuel System Fires

Purpose

This bulletin advises owners and operators of the serious hazards of fires that may result in air-swept pulverized-fuel systems.

Problem

Pulverizer fires may occur and should be considered dangerous. A fire in an air-swept pulverizing system represents a stable but dangerous situation. To extinguish the fire, the pulverizer must be shut down. However, during the shut-down procedure, the pulverizer passes through a potentially explosive fuel-air mixture condition. In some instances, pulverizer system explosions have occurred.

Recommendations

It is necessary to shut down the pulverizer system in a manner that minimizes the potentially explosive mixture and the time during which this mixture can exist.

To accomplish this, the pulverized-fuel systems should be reviewed to determine the adequacies of at least the following operating parameters — ask yourself these questions:

Inerting System


- 1. Is the inerting media sized per the pulverized manufacturer's specifications?
- 2. Is the inerting system located away from the pulverizer to prevent damage caused by fire, corrosion and/or explosion?

Control System

- 1. Will the control system isolate the mill?
- 2. Will the controls initiate the inerting sequence?

Procedures and Personnel Training

- 1. Are all plant and operating personnel well trained on how to react to the various type of fires?
- 2. Are procedures in line with available guidelines?

Maintenance and Housecleaning

- 1. Are good maintenance practices followed?
- 2. Is maintenance done per the manufacturer's guidelines?
- 3. Are good housecleaning practices followed?

If you are unsure of any answers to the preceding questions, the following should be reviewed:

- The Manufacturer's Operating and Maintenance Instructions and Procedures
- The latest Guide Specifications for isolation, inerting and clearing the pulverizer system
- The applicable National Fire Prevention Association (NFPA) code

When a pulverizer system fire is suspected, it is strongly recommended that the areas above, around and below the hazardous location be cleared of personnel.
